CONTRACTOR LICENSING INFORMATION

LICENSE CATEGORIES:

- Class A** For construction of any and all types of structures
- Class B** For construction of structures up to and including three (3) stories
- Class C** For construction of one (1) or two (2) family dwellings
- Class D** For construction of residential additions or remodeling of residential structures including construction of residential garages, decks, patio covers and similar work

CONTRACTOR LICENSE CATEGORIES AND LICENSE FEES:

General Contractors:	Unlimited General Contractor "A"	\$165
	Limited General Contractor "B"	\$110
	Residential/General Contractor "C"	\$80
	Residential/Remodeling Contractor "D"	\$80
Subcontractors:	Mechanical, Roofing, Sign, Elevator, Drywall, Excavation, Fire Protection, Fence, Lawn Sprinkler, Mobile Home Installers, Concrete Flatwork, and Asbestos Abatement	\$75

Qualifications/Requirements:

- Class A:** Requires Standard General Building Contractor (A) exam certificate issued by the International Code Council.
- Class B:** Requires Standard Building Contractor (B) exam certificate issued by the International Code Council.
- Class C:** Requires Standard Residential Contractor (C) exam certificate issued by the International Code Council.
- Class D:** Requires Standard Residential Contractor (C) exam certificate issued by the International Code Council. The Building Official may make exceptions in this category. Please contact the Building Safety Division for further information.
- Mechanical:** Requires Standard Master Mechanical Contractor exam certificate issued by the International Code Council.
- Roofing:** Requires Roofing Contractor/Subcontractor exam certificate issued by the International Code Council.

Plumbing and Electrical Contractors:

Please provide a copy of your current Master License and State of Colorado Contractor Registration in addition to a certificate of general liability. There is no fee for your registration.

Insurance Requirements:

To obtain a contractor's license, you are required to provide a current certificate of general liability insurance, with the City of Commerce City listed as certificate holder (see the City of Commerce City Ordinance: Sec. 5-40 {Code 1969, § 10-101; Ord. No. 778, 11-24-86} for more information), for a minimum of \$300,000. If you are unsure whether the City has your current certificate on file, please contact our office.

Please refer to your current license for your specific license classification, to assure that your payment is for the correct amount. Please reference your contractor's license number on your check, which should be made payable to the City of Commerce City.
