Resident survey returns to gauge community livability

Commerce City is once again participating in the National Community Survey™ (NCS) in 2025 to collect resident feedback about the overall livability of the city. The survey captures opinions on the economy, mobility, community design, utilities, safety, natural environment, inclusivity, engagement, and more. The results show Commerce City's strengths, areas of improvement, and what matters most to residents.

City Council and staff will examine the survey results and can use data from the NCS to inform continuing conversations with community members about what the city is doing well and what can be improved. Surveys have been mailed to approximately 3,000 residents selected at random but equally distributed by ward boundaries across the city. Recipients will have six weeks to complete and return the survey. The survey then becomes available for open participation in late October, with data collection closing Nov. 10. New session of free GED preparation classes begins Oct. 27

Commerce City residents looking to complete their high school equivalency diploma have another opportunity this month through the city's Workforce Pathway Program. Funded by the American Rescue Plan Act, this is part of the city's larger Advancing Commerce City Together (ACT) program, which invests in education and career development to strengthen both individuals and the community. Through a partnership with Metropolitan State University, the GED Preparation Program provides free courses in English and Spanish to help residents prepare for GED testing.

The next session will begin on Monday, Oct. 27, with in-person registration required the week before. Register in person during one of the following times at Central Elementary School (6450 Holly St.):

- Monday, Oct. 20 at 5:30 p.m.
- Tuesday, Oct. 21 at 9 a.m.
- Thursday, Oct. 23 at 5:30 p.m.

DID YOU KNOW?

The Regional Transit District (RTD) serves 65 million passengers annually with a network covering 40 municipalities. Their vehicles travel approximately 135,000 miles every day! This includes 10 train routes, 85 bus routes, 12 regional bus routes, and 5 DEN SkyRide routes in Commerce City. The city's N-Line light rail has a station at 72nd and Colorado, with connections to 49, 72, 88, and 88L buses. Several of these also connect to the A-Line train to DEN and Union Station. Two other routes pass through, the 104L between Northglenn and the Airport, with a Parkn-Ride near 104th and Highway 2, and the XL regional service between downtown and Brighton passes on Brighton Blvd and Highway 85. Vehicles with license plates registered to an address within the RTD district may park for free for up to 30 days at the 104th Park-n-Ride and the 72nd Ave train station (this is not the case at all RTD parking lots).

Hot Shot Crew


Monday - Friday

- During the past work week, the Hot Shot crew was a two-person team that worked eight hours per day.
 Clean-up efforts are dedicated to both scheduled locations of known hotspots and in response to AccessC3 requests.
- Hot Shot crews conducted inspections and removed abandoned items at the following scheduled, routine locations:

 - E. 112th Avenue and Tower Road
 - E. 120th Avenue and Cameron Street
 - Elm Street E. 69th Avenue to 72nd Avenue
- In addition to routine areas, crews performed cleanup at the following locations:
 - 56th Avenue and Dahlia Street
 - 60th Avenue and Dahlia Street
 - 72nd Avenue and Dahlia Street









Distinctive Highlights

- This week, our dedicated Hot Shot team picked up an astonishing 73 tires throughout the city. Crews locate and identify tires through the resident reports via Commerce City's AccessC3 system and through routine inspections. Once collected, staff transport the tires for proper recycling and disposal to eliminate potential hazards.
- During routine route inspections, teams found a large dumping of tires, cardboard, and other debris near 48th Avenue and Ivy Street (pictures top right). Crews were quick to act, removing the debris and disposing of any harmful materials that were found in the area.
- Crews received another report of a large dumping of furniture, debris, and trash near 56th Avenue and Dahlia Street. Crews removed the garbage and cleaned the area.



PW Updates

Preservation and Safety

- This past week, the Streets Operations team took time to replace the circuit boards on school zone flashers on 68th Avenue and Colorado Boulevard.
- The snow season is right around the corner, and various divisions within Public Works are working to prepare for the upcoming weather. Staff have been training and completing maintenance for winter snow operations. When the snow starts to pick up, use Commerce City's "Snow Trooper" website to track in real-time where the City's plow trucks are located throughout Commerce City's streets. Streets

- This week, sweeping operations were underway as the street sweepers swept through the city-established District One, route #4. The streets that were swept were E 60th Avenue, Quebec Street, E 64th Avenue, and E. 72nd Avenue.
- This week, the Street's team began preparing equipment and materials for crack sealing operations and shoulder repairs throughout various parts of Commerce City.
- Through a combined effort of many teams and departments throughout Commerce City, traffic control operations were in full effect for this year's Adams City High School Homecoming Parade! Streets' staff drove five plows throughout the parade route that were decorated by our local Adams City High School students!

Parks Operations

- Parks teams completed renovation and maintenance touch-ups at the restrooms at Veteran's Memorial Park and Prairie Gateway Open Space and Trail. Teams painted the restrooms and added an epoxy coating to the floors at both sites to increase durability, improve safety, and create a seamless surface.
- Staff prepared for the Fall Fest event at Veterans' Memorial Park on Saturday, October 4. Teams removed weeds throughout the park and pressure-washed and sanitized the playgrounds, shelters, and sidewalks.
- Teams continued with fall turf aeration, targeting Pioneer Park, Fairfax Park, and Monaco Park this week. During aeration, staff create openings in compacted soil to improve air, water, and nutrient flow to grass roots, promoting healthy growth. Parks crews aim to aerate to prevent water runoff, encouraging deeper root growth and boosting turf health.
- Ballfield prep continues in full swing, with Pioneer Park staff hosting youth baseball at Moore, Capra, and Rolla fields. In preparation for games and practices, teams screen drag the field, set the bases, and repaint the foul lines. These tasks are completed daily and reset weekly.
- Staff completed installing a new QR code sign requested by Community Relations on the sidewalk at Veterans Memorial Park. Teams also replaced the flags, in preparation for the upcoming celebration to honor our Nation's fallen heroes in November.
- Teams continue to get ahead of the lower temperatures, working on irrigation winterization throughout the city's sites. This week, teams worked on the irrigation system at Ragweed Draw Trail and Turnberry Park. Crews aim to finish the remaining sites within the next few weeks.

This year's opportunity for a fresh start is on Wednesday, Oct. 15, from 9 a.m. to 3 p.m. at the Civic Center, 7887 E. 60th Ave. You can also participate virtually via Zoom:

Individuals can re-set their cases and have warrants vacated. For those who are eligible, a portion of their total fines owed may be waived or a new payment plan arranged to get cases back on track. Participants can also inquire about sealing records (other than traffic). Each case will be handled differently. Many cases can be resolved and closed, but outstanding restitution cases are ineligible. Learn more at c3gov.com/Court.
