Business/Economic Development



Last Friday, staff welcomed the Leadership Commerce City cohort as part of their Economic Development and Environmental Day programming. The team delivered a presentation highlighting the city's economic development initiatives and current priorities. The agenda also featured guest speakers from Manufacturer's Edge, followed by site visits to 3R Technology Solutions and Stadium Auto & Truck Parts, providing participants with a firsthand look at local industry and business operations.

Staff provided land development business liaison support for the properties at the southwest corner of 96th Ave. and Tower Rd.

Staff met with leadership from the Community College of Aurora, Adams 14 School District, and Rocky Mountain Partnership to discuss new opportunities for collaboration as part of the Workforce Pathway Program. CCA and Adams 14 will be continuing discussions for support on adult education and concurrent enrollment programming. CCA and the city will also be exploring new opportunities for expanding the existing workforce partnerships.

Staff worked with the communications team to craft a flyer for Commerce City Promise that is being sent to all residential addresses in Commerce City. The next deadline for enrollment in programming is mid-January.

Staff held it's bi-weekly meeting with Elasticity to continue preparation for the launch of a new advertising campaign in Q1 of 2026 focused on business attraction.

Our new Economic Development website is nearing completion and launch with inclusion of new maps, photography, and videography.

The business survey is still live and available for businesses to complete at www.surveymonkey.com/r/M8Z8ZH2. Staff and the communications team have crafted an Elevate Commerce branded postcard that will be sent to all business addresses in the city to seek higher engagement with the survey.

Staff hosted this month's session for the Leadership Commerce City program. This Adams 14 Foundation initiative aims to educate future local leaders on the workings of Commerce City and with it imbue lessons of leadership. This session was focused on Economic Development and the Environment. It included presentations by city staff, Manufacturer's Edge, hands on activities on the inner workings of the Economic Development Department and visit to two local businesses (3R Technology Solutions and Stadium Autoparts).

Staff participated and completed all required activities for the IEDC's Credit Rating in Economic Development course, which is required to obtain the CEcD certificate.

The city collaborates with our neighbors through a regional advocacy organization called the Adams County Regional Economic Partnership or AC-REP? The organization represents all 10 Adams Community cities, plus unincorporated communities like Henderson, Strasburg & Watkins.

 - Elm Street E. 69th Avenue to 72nd Avenue







Distinctive Highlights

- This week, Hot Shot crews continued with their dedication to remove large objects and debris from the city's roadways.
- During routine inspections, teams removed 55 tires from the City's right-of-way (ROW). Crews remove every tire with careful determination to provide safe roadways for motorists.
- Every week, Hot Shot teams collaborate with the Regional Transportation District (RTD) to provide clean trash receptacles in the Derby area. Staff are dispatched to the site every Friday to replace the trash bags and provide clean ones for residents.





Family Offers \$10,000 Reward for Information That Helps Solve Deadly Hit and Run

Can you help the Bern family finally begin the arduous healing process?

Just over three years ago, in the middle of the night on Nov. 15, their son Matthew Bern was struck and killed by a vehicle as he was walking in the 5800 block of Holly Street.

That vehicle-- believed to be a maroon 2009 to 2014 Ford F-150 briefly stopped and a witness described a white or Latino male with a beard and shoulder length hair getting out, seemingly checking his truck, then driving off without helping Matthew.



We've never been able to locate the suspect, and the Bern family still doesn't have closure; Matthew's death from a hit and run has left them with so many painful questions.

They've partnered with Metro Denver Crime Stoppers to offer a \$10,000 reward for information leading to an arrest in this tragic case. We know someone knows something-- are YOU that someone? Call 720-913-STOP (7867) with tips and help us get justice for Matthew Bern and those who loved him.

 He attended Metropolitan State University and spent the last decade working in sales until deciding to follow in his uncle's footsteps.

We could not be prouder of their success and are excited for them to begin field training with our experienced officers! Congratulations, lady and gentlemen! This is just the beginning.

PW Updates

Preservation and Safety

This week, many divisions from the Public Works Department kicked off their snow season with their first snowstorm. Fleet, teams were on-call for pre-trips to inspect and prepare all equipment for snow operations. Streets and Parks Operations worked collaboratively during the snowfall to remove snow from the City's buildings, parks, trails and roadways. Teams switched off on-call throughout the entire 24 hours of the snowfall to ensure the snow was removed and residents and commuters were able to safely get to their destinations. We are grateful for such dedicated staff!

Streets

- This week the Streets' division received over 20 requests to replace damaged or downed signs throughout Commerce City. Crews were quick to respond, totaling 22 new signs placed citywide. Teams identify the signs that are needed and then print replacements at the city's very own sign shop. 13 of the 22 signs these week were made in-house, and eight more were printed with aim to be installed next week.
- A new traffic control speed check sign will be coming up along 72nd Avenue and Colorado Boulevard. Teams set out the equipment for the sign this week and are waiting on the base to complete the installation.
- Teams completed a new grading project to level the dirt road between 69th Avenue and 72nd Avenue.
- Pavement teams successfully completed a delineation project at Legato Parkway and Tower Road. Crews installed 10 new plastic delineators to temporarily close one of the turn lanes going in to Tower Road.
- Staff then continued with a thermal pavement marking project along 81st Avenue and Rosemary Street. Teams added the last two pavement markings on the pavement, adding one Only legend and one straight arrow to improve traffic flow in the area.
- This week, teams fixed a total of 30 potholes and failures that were reported throughout the city. Crews estimate to have used a total of 1.5 tons of cold mix asphalt for the repairs.
- Streets teams assisted during the Holiday Tree Lighting event on Wednesday, December 3rd. Teams were dispatched to setup detour signs, Visual Message Boards (VMS), and guide traffic during the event.

Parks Operations

- This week, teams replaced the trail gate rods at Sand Creek
 Trail. Crews identified the need for repairs during routine
 inspections of the park and acted quickly to ensure there were
 no trespassers or more damage to the trail.
- The right-of-way maintenance teams removed a total of 20 bags from US-Highway 2.
- On Wednesday, December 3rd, teams assisted with the setup and teardown of the Holiday Tree Lighting Ceremony. Crews juggled removing the snow throughout the Civic Center and setting up for the event to ensure all visitors had a fun and safe time at the event.
- Teams added mulch to all the tree rings at Fronterra Park. By adding mulch to the trees, crews aim for the trees to retain water in the drier and cooler temperatures. The mulch helps regulate the temperature so the trees can survive the winter.
- Teams repaired the fence at the Villages at Buffalo Run East dugout. Crews collaborated with CIRSA, the Colorado Intergovernmental Risk Sharing Agency, for a thorough inspection of the dugout at Villages at Buffalo Run East Park and the shelter at Fronterra Park. Once CIRSA inspected the small shelter, teams repaired the outlet face cover to ensure it was safe to use.
- The right-of-way (ROW) maintenance teams' duties were halted temporarily due to the snowstorm this week. Crews tackled Highway 2, Tower Road and other high priority areas. In total, teams removed 39 trash bags from the ROW.
