Prohibited Contributions

(Art. XXVIII, Sec.3 & C.R.S. 1-45-103.7(1.9))

- No candidate's candidate committee shall accept contributions from, or make contributions to, another candidate committee.
- No person shall act as a conduit for a contribution to a candidate committee.
- Colorado law prohibits candidates and candidate committees from accepting contributions from:
 - o A corporation (profit or non-profit) or labor organization
 - o Foreign citizens, coporations, or governments
 - o Another candidate committee (local, state, or federal)
 - o Lobbyists, principals of lobbyists, or political committees who retain a lobbyist
 - o Anonymous contributions of \$20 or more
 - o LLC if any LLC members are the above
 - o LLCs that the IRS treats as corporations and from LLCs with publicly traded shares
- No candidate committee or issue committee shall accept a contribution, or make an expenditure, in currency or coin exceeding one hundred dollars.
- No person shall make a contribution to a candidate committee or issue committee with the expectation that some or all of the amounts of such contribution will be reimbursed by another person.
- No person shall be reimbursed for a contribution made to any candidate committee or issue committee nor shall any person make such reimbursement except as provided in subsection (8) of this section (Art. XXVIII, Sec. 3(8)).
- The maximum amount of aggregate contributions that any one person, including a political party, and
 excluding a small donor committee, may make to a candidate committee of a candidate for a municipal office,
 and that a candidate committee for such a candidate may accept from any one such person per election is four
 hundred dollars.
- The maximum amount of aggregate contributions that any one small donor committee may make to a candidate committee of a candidate for a municipal office and that a candidate committee for such a candidate may accept from any one small donor committee per election is four thousand dollars.

*Candidate/Issues Committees are required to disclose occupation and employer for all \$100 or more contributions (Art. XXVIII, Sec. 7). Please refer to Article XXVIII, Section 3 for further information on contribution limits and prohibited contributions.
